

Wendell Swim Club - Pool Party Rental Policies 2018

Pool Party Contact: wendellswimclubofficers@gmail.com

- (1) Pool party rentals are only authorized for shareholders of Wendell Swim Club in good standing, with all dues and fees paid.
- (2) Only one party may be reserved at a time, by contacting the pool party contact named above. Check the [pool calendar](#) to view scheduled events. Once a party date/time is scheduled and approved, the pool party contact will place it on the pool calendar. If hours overlap with member-at-large use, their right to enjoyment of the facilities must be respected.
- (3) WSC functions including Swim Team have priority over party rentals. No party rentals will be reserved at times required by the club for events such as swim team practice and swim meets, shareholder meetings, holiday events, swim lessons & group water activities
- (4) The shareholder must be present during the entire function and will be held responsible for any damage or loss to club property, equipment or furnishings. No tape or tacks may be used on walls, doors or ceilings of the clubhouse. A tack strip is located near the ceiling for hanging decorations. The renter assumes full responsibility for oversight and supervision of the event for the safety and well-being of their guests. Since the club is a family-oriented recreational facility and small children are often present, it is expected that shareholders and guests will exhibit decent and respectable behavior.
- (5) The shareholder is responsible for hiring lifeguards to staff the party according to the requirements of the pool management company. Information on lifeguards for pool parties and party registration with AquaTech is here:

- (6) Clean-up is the responsibility of the shareholder. It is expected that the renter will sweep floors (or mop if needed), clean tables and chairs, counters, kitchen sink, and remove any of your food placed in the refrigerators. Club utensils or equipment used must be washed and returned to the proper storage areas. (Concessions equipment is not to be used.) Food and debris must be removed from the pool deck and lounge chairs returned to the flat position. No food or drink is allowed in pool or beyond red lines on the deck. Lifeguards will advise as needed.
- (7) A \$25.00 security deposit by check is required in addition to the WSC rental fee. If the facilities are left clean as stated above and in undamaged condition and there were no complaints or injuries, the deposit check will be voided and returned to the shareholder. If there is damage or other issues related to negligence, suitable payment will be required.
- (8) Rental fees differ for day and evening parties. See the following reservation form. For evening parties scheduled after normal pool operating hours, please note that our pool is not permitted by Wake County to operate after dark. Parties must end and the pool must close at dark, as determined by the head lifeguard or manager on duty.
